These terms and conditions are intended to:

- Safeguard Devon County Council's interest in the heritage collections which it has acquired over the years
- Preserve the collections on behalf of the people of Devon
- Protect any intellectual property rights in the material held
- Where appropriate, generate income to sustain the collections
- Support initiatives to make material in the library's collections more widely accessible while ensuring their conservation

We are happy to work with organisations and individuals who are undertaking community heritage projects.

We reserve the right to refuse permission to copy or use material on grounds of conservation, copyright, prejudicial use or any other reasons. Staff time may limit the number of permissions that we are able to grant, and the time that it will take for an order to be completed. As a guide, a small order is likely to require 7 working days to complete order and a larger or more complex order may take 28 days.

General terms and conditions

1. Copies of Library resources will only be supplied if a licence agreement form has been completed and signed.
2. The agreement licences non-exclusive single use of material only for the purposes of the publication or broadcast specified and any publicity directly associated with it. If the applicant wishes to make any other use of the material, a specific agreement will be required, which may include a further reproduction fee or royalty payment.
3. Acknowledgement must be made in the publication or reproduction for any material used, using the wording set out in the licence agreement.
4. Where applicable, the applicant must make every effort to obtain the written permission of copyright holders or other intellectual property owners of materials to be included in publications or broadcasts. Devon County Council will not be held responsible for any infringement by applicants.
5. Nothing in the agreement or in the terms and conditions creates any exclusive right of publication as far as the images are concerned. In particular, Devon County Council remains at liberty to grant permission for publication of the images to anyone else seeking such permission.

6. Fees as detailed below are payable for each image, whether for private use or for publication / broadcast.
7. An additional fee as detailed below is payable for the publication or reproduction or broadcast of images. All fees are payable to Devon County Council.
8. The term "private" includes private research or study, or the display of an image in a private home.
9. The term "broadcast" includes all forms of electronic reproduction such as a TV programme or inclusion on a website.
10. The term "publication" includes all forms of printed reproduction such as a book or journal or leaflet, and the display of an image anywhere other than in a private home.

Publication / broadcast fee

1. Additional fee of £50 for the inclusion of one or more images in a specified publication or broadcast.
2. Further additional fee of £25 for any subsequent editions of a printed publication (normally indicated by a new ISBN).

In the case of printed books, the additional fees will be waived if 2 copies of the finished work are sent free of charge to Devon Libraries within 14 days of publication.
