

# Carers Allowance

## What is Carers Allowance?

Carers Allowance is a benefit for people over the age of 16 who regularly spend at least 35 hours a week caring for a severely disabled person.

## What do you mean by 'severely disabled'?

To qualify for Carers Allowance the 'cared-for' person must receive one of the following:

- Disability Living Allowance **care** component paid at the middle or higher rate.
- Attendance Allowance paid at either rate
- Constant Attendance Allowance (of £52.70 or more) paid with a War Pension, Industrial disablement Pension, workmen's compensation or an equivalent benefit.

## How much is the allowance?

The basic rate from April 2011 is £55.55 per week for the carer, and in some cases additions are made for adult dependants

## I work part time but still care for my mother, can I still claim?

If your take-home pay is less than £100.00 per week you can still apply for Carers Allowance. The earnings limit is after deduction of tax, NI, half of occupational pension and other expenses paid because they are a necessary part of the job'

## Can you claim Carers Allowance if the person you care for is not related to you?

Yes, you do not have to be related to, or live with, the disabled person

## Can I claim Carers Allowance as well as my retirement pension?

No, you cannot be paid Carers Allowance while you are receiving the same amount **or** more from the following benefits:

- Incapacity Benefit
- Unemployment Supplement
- Contribution-based Jobseekers Allowance
- Widows and Bereavement Benefits
- State Training Allowance
- Retirement Pension

This is known as the 'overlapping benefits' rule

## So, what is the point in applying if, like me, you are retired and looking after your husband?

Whilst your household income might not be greater after claiming Carers Allowance, you might be entitled and be awarded what is called an **underlying entitlement** to the Allowance. This means that a Carers Premium is included in your Income Support claim, Job Seekers Allowance, Housing Benefit, Council Tax Benefit or NHS Benefits, and could mean extra allowances. Or, it could mean that you are now entitled to one of these benefits

There are also other benefits for Carers, who are under pension age, such as:

- National Insurance Contribution Credits
- £10.00 Christmas Bonus
- Help towards satisfying the contribution conditions for Incapacity Benefit and Job Seekers Allowance.
