

Safeguarding Adults Level 1 Training

The training builds on the Safeguarding Awareness, MCA and DOLS Training accessed through e-learning and aims to:

- Develop the competencies required by staff who work with vulnerable adults
- Provide the knowledge and skills required to recognize, respond to and report abuse
- Develop awareness of the Mental Capacity Act and the Deprivation of Liberty Safeguards and how to use them in practice

It will be provided as a 1 day course and will enable staff to feedback on practice experience and learn from their colleagues.

Who is the training for?

The training is open to all staff in the private, voluntary, statutory and independent sectors who have direct contact with service users. It is not appropriate for ancillary staff.

Those attending must have completed the Safeguarding Adults, Mental Capacity Act and Deprivation of Liberty Safeguards e-learning.
