Notice is hereby given that an Inspector will be appointed by

**(1) Devon County Council
(Restricted Byway No. 12, Pilton West and Nos. 29 & 30, Shirwell)
Definitive Map Modification Order 2006**

**(2) Devon County Council
(Restricted Byway No.31, Shirwell)
Definitive Map Modification Order 2006**

and will attend at:

on Thursday 6 September 2007 at 10.00 a.m.

To hold a public local inquiry into the Orders

The effect of the Orders, if confirmed without modifications, will be:

(1) to add to them:

Restricted Byway No. 29, Shirwell from the Pilton West parish boundary (GR SS 5779 3481) generally south southeastwards for approximately 75 metres to the unsurfaced county road leading to Kingdon's Gardens (GR SS 5782 3475); and
Part of Restricted Byway No. 30, Shirwell from the unsurfaced county road west of Kingdon's Gardens (GR SS 5823 3469) generally northeastwards for approximately 50 metres to near Kingdon's Garden's (GR SS 5828 3471);

and by upgrading:

Bridleway No. 5, Pilton West to Restricted Byway No. 12 from the end of the unsurfaced county road, Smokey House Lane (GR SS 5722 3466) generally east northeastwards and then south southeastwards for approximately 650 metres to the Shirwell parish boundary (GR SS 5779 3481); and
Footpath No. 15, Shirwell to part of Restricted Byway No. 30 from near Kingdon's Garden's (GR SS 5828 3471) generally east southeastwards and then generally northwards for approximately 2025 metres through Raleigh Wood to the minor county road to Collard Bridge (GR SS 5914 3555); and

(2) to add to them:

Restricted Byway No. 31, Shirwell from the end of the unsurfaced county road from Ford Cross at the southwestern end of Cott Down Plantation wood (GR SS 6024 3813) generally northeastwards on a track alongside the wood for approximately 620 metres to the end of the unsurfaced county road from Loxhore Cott (GR SS 6074 3849).
