Summary of Matter or Issue Requiring Decision

Decision to award the contract for CP1033-14 – Provision of Children Centre Service in North Devon and Torridge (Contract A and B), following an OJEU EU tender part B process.

Decision Taken

To award a contract (subject to due diligence) to the below organisation for the provision of the above contract. The contract will commence on 1st May 2015, for the period of 35 Months, with an option to extend for a further 24 months. Action for Children, St David's Court, 68A Cowbridge Road, Cardiff, CF11 9DN

Summary of Reason(s) for Decision Taken

Summary of Alternatives or Options considered and rejected

Children's centre Boundaries/Areas

In light of the consultation responses a number of alternatives were considered when looking at how Devon County Council will contract with providers to deliver children's centre services in future; Maintain the status quo and maintain 41 individual contracts

Currently, this option would mean;

- Budget reductions would make some centres unviable
- Lack of potential opportunities for the Responsible Bodies to achieve efficiency savings in administrative / managerial costs
- Lack of consistency for service delivery
- Requirement of 41 individual Ofsted inspections and time/money resource for both the Responsible Body and Local Authority to support this
- Lack of budget flexibility unable to use resources effectively to meet identified need, changing need and local priorities
- Lack of opportunities to reduce costs associated with data collection, legal support of the procurement process and lease agreements Contract on AXS Cluster basis and reduce to 19 contracts based on groups of Learning Communities.

Currently, this option would mean;

- Lack of further opportunities for the Responsible Bodies to achieve efficiency savings in administrative / managerial costs
- Requirement of 19 individual Ofsted inspections and time/money resource for both the Responsible Body and Local Authority to support it
- Lack of budget flexibility unable to use resources effectively to meet identified need and local priorities
- Lack of opportunities to reduce costs associated with data collection, legal support of the procurement process and lease agreements
- Lack of opportunities to rationalise the Children's Centre estate

Contract on a Devon wide basis and reduce to 1 contract across Devon

Currently, this option would mean;

- Concern around current market capacity to deliver
- Challenging for providers to know the local community and meet Ofsted requirements
- Loss of local identity
- Decrease in market option / competition
- De-stabilise current and future service delivery (early termination of contracts, TUPE)
- At this stage, moving from 41 contracts to 1 would be too radical and a significant change in the delivery model
