Stoptober is back and the Alliance invites you to spread the word.

Stopping smoking for 28 days means you're five times more likely to stop for good. The campaign launches in September, encouraging people to get ready to be part of the challenge. The challenge starts on the 1st October. It's the same 28 day challenge, but this year uses comedy to help people get through Stoptober and stay smokefree for 28 days (and hopefully beyond).

Government Consultations

Smokefree Vehicles Carrying Children

The Children and Families Act 2014 gave the Secretary of State for Health the power to legislate against smoking in vehicles to protect children's health. The Alliance has responded to the recent consultation covering smoking in private vehicles. We encourage the denormalisation of smoking and wish to protect children from the



harm of tobacco smoke in cars. Banning smoking in cars carrying children is a <u>campaign</u> led by the British Lung Foundation and has the strong support of MPs.

Second-hand smoke is particularly dangerous in the car, where even with the window down or air conditioning on, smoking can result in dangerous concentrations of toxic chemicals – many of which are invisible to the naked eye.

Standardised Packaging of Tobacco Products: Draft Regulations



The Alliance has also responded to a consultation on draft regulations for plain packaging of tobacco products.

Public Health England published figures last month, revealing the potential benefits that standardised packaging of tobacco products could bring, not only for health, but to the economy – providing a real economic boost to the most deprived communities.

This follows data from Australia, where standardised packaging was introduced in December 2012. It showed a 3.4% fall in tobacco sales by volume in the first year following the introduction of standardised packs. If that fall in sales is mirrored here, Public Health England predicts that total savings across the South West would be up to £48 million. With tobacco a major cause of health inequalities – the greatest harm being suffered by the most disadvantaged – the benefits would be most felt in areas of greater social deprivation.

Teignbridge District Council Signs Local Government Declaration on Tobacco Control

In July, Teignbridge District Council signed up to a statement of intent to do all it can to help reduce smoking rates among its communities as well as highlighting the harm smoking causes. The council joins Exeter, South Hams, West Devon, Plymouth and Devon local authorities in the county, in taking comprehensive action to address the matter. Teignbridge is a key partner in the Smokefree Devon Alliance and committed to securing the health, welfare, social, economic and environmental benefits that come from reducing smoking prevalence.

Cllr Sylvia Russell, Teignbridge District Council's Executive Portfolio Holder for Health and Wellbeing, said:

"Teignbridge has already done some really good things to encourage people to stop smoking. Last year we introduced three 'smoke free' play areas in Teignmouth and Newton Abbot so children were not exposed to cigarette fumes as they played."

Illegal Tobacco

Smokefree South West ran a successful Exeter event in July , as part of <u>its Illegal Tobacco Campaign</u>. The event team engaged with 567 shoppers to explain the problems that cheap tobacco can bring to the community. Twelve pieces of high quality information were received and forwarded to the Regional Intelligence Analyst, with many more people taking the contact details of Crimestoppers. Most people don't realise that cheap tobacco makes it easier for children to smoke, keeps adults smoking and is closely linked to serious crime.




Smoking Statistics for Young People

The annual national Smoking, Drinking and Drug Use 2013 survey has recently been published. It shows that the



prevalence of smoking in young people has once again fallen. 3% of pupils reported that they smoked at least one cigarette a week (the survey definition of regular smoking) . In 2003, this was recorded as 9%. Smoking prevalence in the age groups are recorded as:

2014 Health Profiles

Public Health England has published its annual Health Profiles and smoking prevalence in Devon continues to fall. It should be noted, however, that there are pockets of Devon where prevalence is much higher.

The Cost of Smoking in Caring



Action on Smoking and Health (ASH) has published a <u>report</u> quantifying the cost of adult social care to local authorities for smoking related disease such as COPD, strokes and cancers. For every person that dies from smoking, twenty are living with a smoking related disease. Smokers not only die younger but need care on average nine years earlier than non-smokers. The research assesses the cost of smoking related illness to the social care system for each local authority, and for Devon County Council it is £9,613,350.
